I went on to the University of Toronto where I collected a B.A. in modern languages, a B.L.S. and then an M.L.S. from the faculty of library science, a M.Ed. in adult education, and a Ph.D. in Canadian studies.

Throughout most of my working life, I always kept a foot in both the public and private sectors, working as a librarian, at TVO, as an editor, and as a college professor. An interest in money management led me to the Canadian Securities Institute where I acquired another set of funny letters and subsequently worked in the financial services industry. I am presently enjoying life with my rescued Portuguese Water Dog, Toby, and am planning to begin a B.F.A. at York University.

Summary of the Membership Survey, 2007

Last year we surveyed MRBS members to get an idea of how committed the members were to the organization and how satisfied they were with its services. We needed to know if our efforts were bearing fruit and if the members thought that the organization served a useful purpose.

While we posted the frequency tables showing the numerical results of the Membership Survey on our MRBS website last year, we did not provide a verbal account for those who do not have computers. The results are summarised as follows.

A total of 168 Malvernites returned their questionnaire; 132 by email and 26 by Canada Post, within a few weeks of our sending it out in May 2007. Out of a total database of 2900, this response may seem small but it is not unusual for such polls. Note that the persons who responded were a sample of our most interested members. The percentages below are based on the tabulation of the email responses, but the two sets of responses were almost the same except that the email respondents expressed more enjoyment that the MRBS exists.

The responses to each question can be summarised in a single sentence. The majority agreed or strongly agreed (69%) that having the society in existence had brought enjoyment to them, and 60.6 % thought that the society was THEIR MRBS. Just under 51 % planned to attend a future meeting or reunion. Nearly 60% agreed or strongly agreed that the quorum of MRBS member should equal those who attend an Annual General Meeting. An impressive 54.5 % of members always read MRBS communications, and 31.1 % read them sometimes. The website was somewhat less used, with just over 20% of respondents visiting the website often or very often and nearly 64% saying that they never or rarely visited it.

As for being willing to pay a nominal membership fee if necessary, some 45% were willing or very willing to do so. Only 12% of

respondents felt that it would not matter to them if the MRBS no longer existed, 17.4% were undecided, and 67.4% felt that it would matter to them.

The question about group benefit programs (e.g. group insurance) elicited the most negative response. Only 14.6 % saw value in having them, 43.2% were undecided, and 39.4% disagreed or strongly disagreed with having them made available to MRBS members. However, 47% thought that for such programs to be effective, they needed to be informed of such programs.

The policy implications of these results approved at the MRBS Executive meeting in July 2007 were as follows:

- a) We need to revise the Constitution to allow for a quorum at the AGM to equal the attendance.
- b) We voted to not renew the contract with Johnson Insurance when it lapsed in 2007. This suited them also as our agreement with them had not yielded enough sales to make it worth their while.

NOTICE OF PROPOSED CHANGE TO THE MRBS CONSTITUTION

The Executive of the MRBS are proposing a change in the MRBS Bylaws. The aim is to regularise the acceptance as a quorum of the total number of those present at the Annual General meeting, as members do not show up in large numbers for the AGM. The proposed change is worded as follows: “Quorum, for meeting of members, for the transaction of business of any meeting of the members, shall consist of four (4) directors and as many members as are present (replaces twenty (20)).” Please send any comments on this proposal to the MRBS if you wish before we vote on it. A two-thirds majority vote of the Executive is required to change the Bylaws.

Highlights of Presentation to Annual General Meeting, 4th November 2007

The MRBS operated on a lean, donations-driven budget in 2006/7. Donations and sponsorship income totalled \$2890.56 while expenses totalled \$3,070.82. The slight deficit of \$180.26 was covered by funds from the cash reserve. As of November 4, 2007, cash on hand was about \$2,760. We expect the current year to be similar to last year in terms of donations generated from members to cover most operating expenses.

Here are some facts about our financial model.

Each year

- We expect to generate about \$2,000 to \$3,000 in donations from our members.
- We spend about \$1,200 for each edition of the Musings (paper and e-mailing) and we have committed to doing two editions each year.
- We spend about \$ 200 to maintain the MRBS website.
- We contribute a \$100 Malvern C.I. commencement scholarship award.
- We allocate funds for materials to maintain the archives.
- We try to maintain a cash reserve of approximately \$2,000 which was built up from the large number of donations at the inception of the MRBS in 2004/5.

MALVERN COMMENCEMENT November 2007

Sonya Munro attended the Malvern commencement last November to represent the MRBS and give out the MRBS award. It is still an impressive event when all the Malvern graduates file across the stage to receive their diplomas and awards. There are now so many awards that they are not given out individually

as they were in the past. Instead, a group of presenters gives them out at one time.

Sonya gave us her account: "Everything went well. The band sounded good. The choir did, too. I met a lot of new people, who turned out to either live close to me or knew people I knew. I introduced myself to Russell Pulkys (our MRBS webmaster) at the reception afterwards, and thanked him for all the work he is doing for our website. Maybe they will have a CD of the proceedings. Tom Brown, the weatherman from CTV, gave the speech to the grads. Great evening. I was proud to be there. Onward Malvern!"

AFRICA EDUCATION PROJECT

We have heard recently from Paul Scott ('68) who sent us information about a very worthwhile education project in Africa initiated by two Malvernites from the 1960s, Joanne (Nancekivelle) Elmer and Dale Mann. It is called the OSOTWA Learning Project. In the language of the Maasai, OSOTWA has the dual meaning of creating a relationship between different peoples and providing something to another person without pay.
